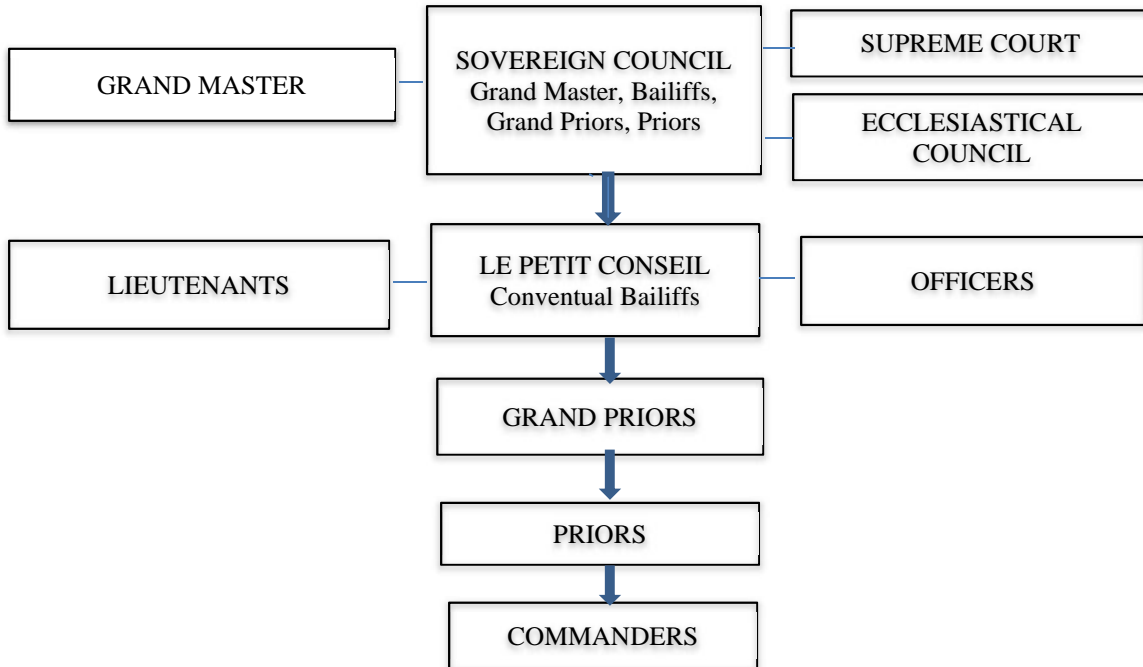


Sovereign Order of St. John of Jerusalem, Knights Hospitaller

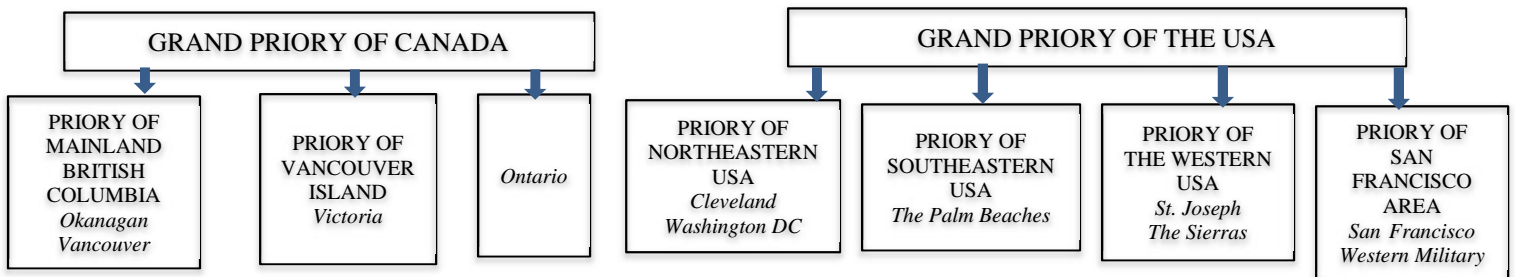
Founded in Jerusalem 1113, continuing through Czar Nicholas II

Pro Fide, Pro Utilitate Hominum

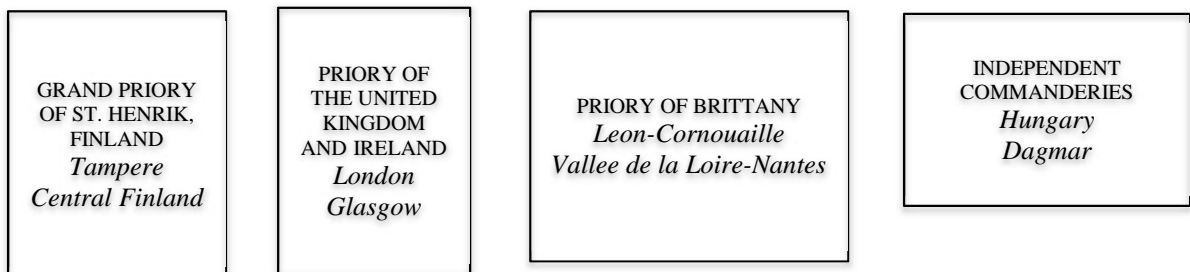
World Structure (as of August 2019)
